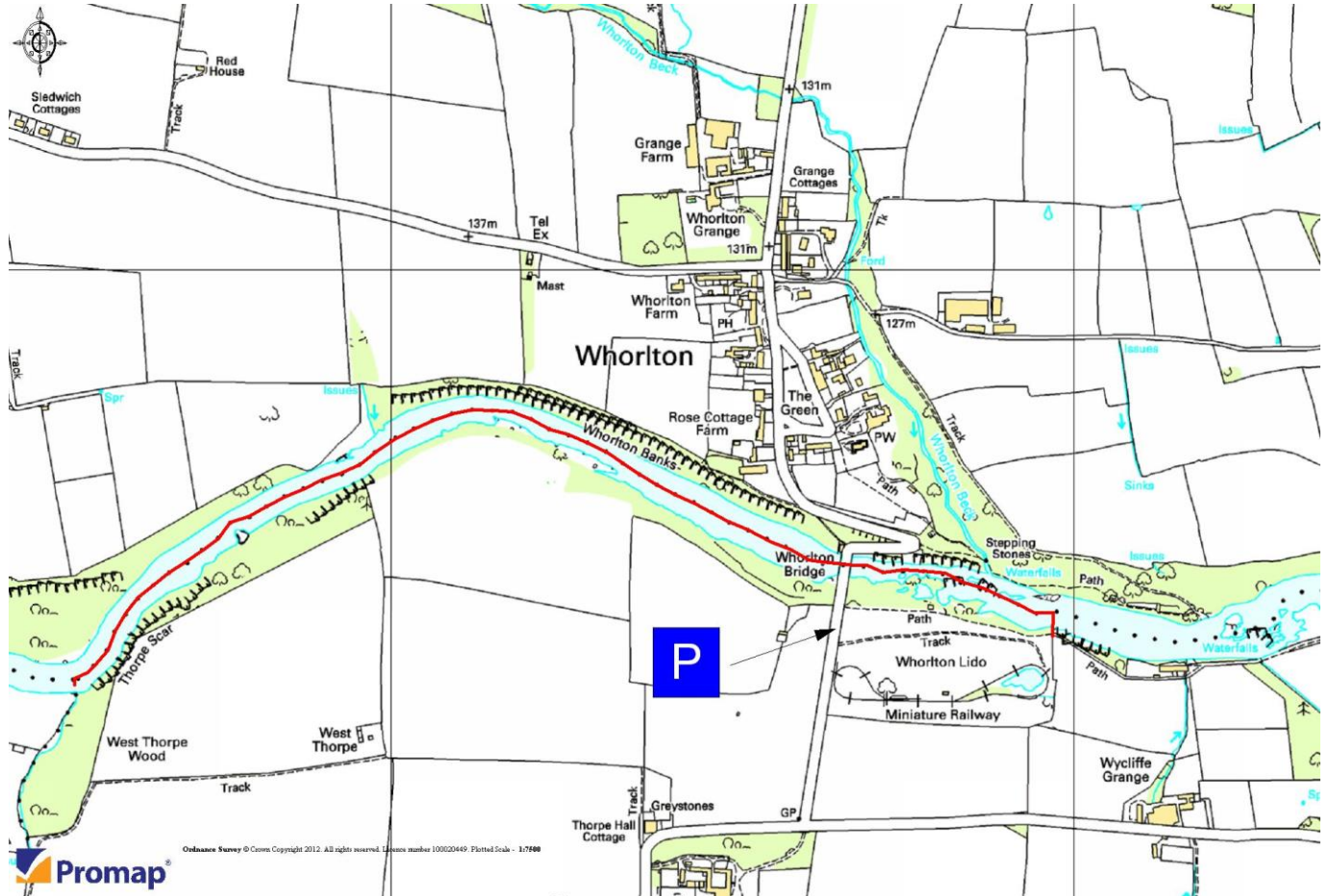

## Overview

- Previously let to a small syndicate of locally based rods and regularly fished
- Encouraging numbers of trout and occasional salmon have been caught

## Location

- The beat is located on the Yorkshire Bank of the River Tees opposite Whorlton Village, some four miles east of Barnard Castle and ten miles west of Scotch Corner.
- The extent of the Beat is as shown on the front cover of these particulars and extends to 1700 metres or thereabouts

## Access

- The Beat is bisected by the Thorpe to Whorlton unclassified road which connects the A66 and the A67 via Whorlton Suspension Bridge.
- Parking is available for up to three cars in a layby provided in the highway verge adjacent to the Bridge and is maintained by Durham County Council
- Access downstream from this point is via the public footpath and thence through locked gates at a couple of locations.
- Access upstream is via the same route, picking up the riverside path that runs westwards.

## Terms

- The Beat is offered for a term of 5 years from 1<sup>st</sup> March 2018 with the rent payable annually in advance
- Vat at the prevailing Rate will apply
- Fishing will be subject to compliance with Environment Agency Byelaws and the possession of an EA Fishing permit by all rods which shall be limited to ten fishing at any one time.
- Fishing by Fly is preferred but the use of spinners and lures will be considered (applicants should make their requirements known when completing the application form below)
- Salmon and Trout are to be included
- Annual Catch returns will be required by 31<sup>st</sup> Jan in each year detailing angling endeavour and fish caught/returned.
- Stocking may be undertaken only with the prior consent of the fishery owner
- No physical works of repair or alteration will be permitted other than path strimming and those agreed in advance with the fishery owner.
- The Tenant will be responsible for their own Bailiffing.
- The Tenant will be required to indemnify the Fishery owner against all claims (inc additional charges) and to hold Public Liability Insurance for themselves and all rods and guests of at least £10 million and to provide evidence of the same when required to do so by the fishery owner

## Reservations

- Shooting Rights are expressly excluded and predator control may only be undertaken by prior consent of the fishery owner and the necessary licences obtained.
- The right for the fishery owner and their assigns to impound, abstract and discharge water from and into the River Tees.
